1. Services Covered

3Skill offers a range of educational services, both online and offline, including:

- Live and recorded certification courses
- 100% internship guarantee programs
- Interview preparation and mentorship
- Technical workshops and soft skills development

All services are provided exclusively via official 3Skill platforms and authorized communication channels.

2. Pricing & Payments

All payments are securely processed through our official payment gateway partner, Easebuzz.

Internship Guarantee Program: Rs. 4,999

Certification Course: Rs. 399

Interview Preparation Course: Rs. 599

Fees are non-transferable.

Applicable taxes and gateway charges may be included in the final price.

3. Refund Policy

Internship Guarantee Program: Eligible for a 100% refund only if the student completes all assigned tasks and does not receive an internship within 3 months.

Certification & Interview Courses: Non-refundable after course access is granted, unless a verified technical access issue is reported within 7 working days.

4. Course Access & Conduct

Login credentials will be shared via email or WhatsApp post-payment.

Students are expected to maintain respectful communication with mentors and fellow learners.

Any misuse of content, harassment, or spamming will lead to immediate account removal without a refund.

5. Intellectual Property

All course materials, including videos, branding, slides, and website content, are the exclusive property of 3Skill.

Unauthorized sharing, reproduction, or distribution is strictly prohibited and may lead to legal action.

6. Privacy Policy

3Skill only collects essential user information (name, contact number, email) for the purposes of:

- Providing services and certifications
- Communicating with students

We do not sell or share personal data with any third party.

7. Legal Jurisdiction

All legal matters will be governed under Indian law.

Disputes arising from 3Skill's services will fall under the jurisdiction of Indian courts, without the requirement to disclose a physical office address.

8. Legal Action for Misuse & Misconduct

We enforce a zero-tolerance policy toward:

- Misconduct with staff or mentors
- Fake submissions (documents, testimonials, reviews)
- Defamation or false allegations on public or social platforms

Consequences may include:

- Immediate account suspension
- Permanent ban from all 3Skill programs
- Forfeiture of refund eligibility
- Reporting to the student's institution (if applicable)
- Legal action under applicable Indian laws

Section 66D - IT Act: Cheating by impersonation using computer resources

Section 500 - IPC: Criminal defamation

Section 504 - IPC: Intentional insult to provoke breach of peace

Section 507 - IPC: Criminal intimidation via anonymous communication
